#### What is Arbitration?

- Third party arbitration is an alternative body (along with a state court) to solve disputes arising out of civil relations
- Forced execution of an arbitral award is guaranteed in 157 countries all over the world according to the norms of the United Nations Convention as of 1958 (New York Convention)

- > Third party arbitration is the rapid dispute resolution procedure in one instance
- The award rendered by the arbitration court comes into force immediately and cannot be subject to appeal

- > Costs per one instance are minimal
- Arbitrators (one or three), the language of arbitration proceedings, applicable law are agreed by the parties. Any citizen of the world can be elected as an arbitrator
- > Confidentiality of the resolution of a dispute is provided by the law
